Once initialing and signing below, it demonstrates my desire to be a part of Forest Lake Academy and the Residence Halls in its entirety as outlined here in this Contract as well as the Dorm Handbook.

- I understand the spiritual nature of Forest Lake Academy. I will do my best to develop and grow a relationship with Jesus. While living here I will do my best to honor Him through my words and actions.
- I understand that to be successful living in the Dorm, I must be a team player and part of the dorm family. This means participating in group activities and worship services. It also means that while living here I will endeavor to do my best at the tasks for which I have volunteered or have been assigned.
- I understand that to respect my Deans, the Dorm and its furnishings, as well as my peers is a high priority. I promise to do my best to uplift others and give them my highest respect and attention.
- I understand that while living in the dorm I am a student of Forest Lake Academy and will uphold all school rules and policies.
- I have read the enclosed Campus Leaves Policy and will live by its guidelines. I understand that campus leaves must be cleared through the Dean on Duty *before* leaving campus and that the driver picking me up is an approved driver and 21 years or older. I also understand that to falsify any information on a weekend leave request slip may result in serious disciplinary action including suspension or dismissal from school.

I understand that if I wish for my personal belongings to be covered by insurance in case of theft or damage I need to secure this insurance.
